INTERNATIONAL 500 PROJECT, INC. VENDOR CONTRACT

PARTIES

This contract is between the International 500 Project, Inc., a Michigan Corporation, herein after referred as "I-500" and _____ of _____ herein after referred to as "Lessee."

SERVICE PROVIDED

In exchange for the below defined consideration, the I-500 will make available and allow the Lessee to market his or her goods or services on the grounds of the I-500 from **Tuesday February 1, 2020 through Saturday February 1, 2020 for outdoor self-contained spaces and Saturday February 4, 2022 for inside spaces**, subject to the restrictions stated in the Invitation to Vendors and the Vendor Contract.

CONSIDERATION

In exchanged for the opportunity, the Lessee will pay to the I-500, the base rate of _____ for Vendor Space Rental. The lease rate payment for Vendor Space Rental is due on or before January 15, 2022, payable to the I-500.

HEALTH DEPARTMENT CONSIDERATION

The Lessee acknowledges and promises to operate their activities in compliance with all Michigan and Chippewa County Health Department rules and regulation. Should there be any fees required by either, the fee will be paid by the Lessee, food vendors Health Department approval is your responsibility.

STRUCTURAL APPROVAL

Should the lessee bring any structure upon the lands of the I-500, said structure will be subject to the approval of the I-500.

NON-PROFIT ORGANIZATIONS

It is acknowledged and understood that the I-500 will give preference to nonprofit organizations or local organizations should there be a shortage of space for the concessions.

VACATION OF PREMISES

The Lessee promised to vacate the premises no later than the day following the race by 2:00 pm. The Lessee acknowledges that he or she must leave the I-500 grounds clean and free of litter or debris caused by their sales.

INDEMNIFICATION

The Lessee will indemnify and hold harmless, the I-500 for any, and all claims, lawsuits or judgments rendered as a result of the Lessee's activities contemplated under this Contract.
