

57th Annual I-500 Camping Registration Lottery Entry Form & Rules

Due to the high demand for camping sites at this event, all sites are awarded via a lottery system with a drawing to be held during the first week of January. To be eligible for the lottery, interested parties must complete the following steps. **New this year, there is a nonrefundable \$25.00 application fee for front-row spots.** Please enclose two checks, one with your application fee and one with the camping fee.

- 1.) Print this page and fill out the form located at the bottom.
- 2.) Mail the completed form along with a self-addressed stamped envelope to:

- 3.) All entries must be postmarked from December 1st, 2025, through December 31st, 2025
- 4.) Entries postmarked before or after the dates indicated will be excluded from the drawing.
- 5.) A check for \$125 payable to "Sault Salmon Derby" **and a check for \$25 payable to "Sault Salmon Derby"**, must be included with the lottery entry form.
- 6.) Please check whether you do or do not wish to be considered for a back-row spot if you are not a recipient of a first-row spot.

I-500 Camping Rules

1. The first permit must be always posted in a visible location.
2. The second camping permit is for coming to and leaving from the I-500 grounds and must be visible when in the camping area.
3. No slide-outs or camper extensions can be used and/or must remain in the closed position if the camping unit is equipped with the slide-out feature.
4. Electricity is only provided in the first row (not the back rows) and is limited to one (1) outlet per camper.
5. Only vehicles with a visible camper permit will be allowed in the camping area on race day.
6. The camper must be centered, as close as possible, to the site number and must not be closer to the thoroughfare than the bucket provided by the I-500 Project, Inc.
7. The bucket shall not be moved.
8. The I-500 Project, Inc. is not responsible for lost, stolen articles or damaged property.
9. Campers must be removed from I-500 property no later than one (1) week post-race. Failure to remove the camper within this timeframe will result in the loss of camping privileges.
10. All propane tanks must be secured (tied down).
11. Only wood may be used to secure campers. Concrete blocks or bricks are not permitted.
12. Failure to follow any of the rules indicated above will result in the loss of camping privileges.
13. No refunds will be issued for any reason.
14. **Campfires must be contained within a standard 2' x 3' fire ring or steel barrel.** Only standard firewood such as soft or hardwood may be burned.
15. Animals are NOT PERMITTED on the I-500 Grounds.
16. All ATV's, UTV's, Side by Sides, and Snowmobiles are to be parked in the general parking lot unless a special permit is obtained from I-500 Security.
17. Temporary shelters such as tents, umbrella structures, and other non-permanent structures are not permitted on the I-500 Grounds without the express written consent of the International 500 Snowmobile Race Board of Directors.
